

OPA's legislative victory makes social media waves



News of the legislature's passage and Governor Kasich's signing of House Bill 188 (HB188), Consult Agreements and Emergency Refill Dispensing, quickly spread like wildfire across the Internet. The December 9, 2015 HB 188 announcement topped nearly all previous posts on our *Twitter* and *LinkedIn* pages, with several legislators, members of the media, and pharmacists sharing, liking, and engaging with the posts.

The news of the Governor's signing of the bill made its way around the U.S. and the world starting in Ohio, to Alabama, South Carolina, Texas, California, and all across the country. It eventually made its way to Canada, Norway, Angola, Pakistan, India, Kenya, England, South Africa, Mexico, Egypt, Indonesia, Israel, China, and many other countries.

U.S. Senator Sherrod Brown speaks at the OPA Awards Luncheon!

On Friday, April 15, we are honored to be joined by one of the lead sponsors of pharmacist provider status legislation at the federal level, United States Senator Sherrod Brown!

During the OPA Awards Luncheon, Senator Brown will discuss pending health care legislation at the federal level - most notably S.314, the Pharmacy and Medically Underserved Areas Enhancement Act, otherwise known as "provider status" for pharmacists.

His remarks will have a big focus on "provider status" and access to pharmacist care, which are considered chief policy goals for national and state pharmacy organizations, and would have a major impact on evolving the role of the pharmacist on health care teams. If passed, the law would have an immediate benefit by giving seniors much-needed access to pharmacist services. 2016 Student Legislative Day - A Success!

On February 23, more than 250 students attended OPA's Student Legislative Day at the Statehouse in Columbus. An opportunity for students to learn more about the legislative process, Student Legislative Day is the first step to becoming actively involved in advocating for the profession. During this one-day event, students were walked through the process of meeting with a legislator, learned about important pharmacy issues and advocacy opportunities, and participated in prearranged meetings with their state legislators. Students from all seven colleges of pharmacy met with more than 90 legislators and legislative aides over the course of the day. During these meetings, they were able to share real-life pharmacy experiences with legislators and educate them on the practice

of pharmacy in Ohio. For many students, this was their first opportunity to visit the Statehouse, and for many more, their first chance to meet with those who represent them at the state level. Students were seated according to their senate districts allowing them to network and make connections with student pharmacists from other schools who live and work in the same area. Overall, it was a great day of

making connections, learning about advocacy, and moving the profession forward.

Representing all seven colleges of pharmacy, more than 250 student pharmacists met with 90 Ohio legislators and legislative aides.

OPF provides education, research to support pharmacists

The mission of the Ohio Pharmacists Foundation (OPF) is to provide educational programs for pharmacists and consumers of health care that enhance the practice of pharmacy and patient outcomes, and to conduct research to support these efforts. As pharmacy practice has expanded to include patient-care services such as immunizations and medication therapy management (MTM), OPF has offered cutting-edge programs to meet the educational needs of pharmacists and pharmacy technicians.

In addition to our immunization training, we have partnered with APhA to offer certificate training programs in MTM and diabetes care. These programs have sparked enthusiasm for the profession and an interest in pursuing provider status for pharmacists. The ability of pharmacists to provide MTM and other patient-care services is one of the first steps in being recognized as a provider. OPF will continue to offer educational programs to support pharmacists who provide these services, as well as pharmacists who will soon take on expanded roles under collaborative practice agreements.

Conference Sessions to Meet New Ohio CPE Requirement

This Annual Conference includes two sessions (0.15 CEU each) to help pharmacists meet the newest Ohio Board of Pharmacy continuing education requirement:

- Tools to Help Pharmacists Prevent Medication Errors on Friday at 8:15 a.m.
- How Safe is Your System? Notable Medication Safety Concerns of 2015 on Sunday at 9:55 a.m.

Ohio-licensed pharmacists must now complete 2 hours (0.2 CEU) of continuing education in patient or medication safety per CPE reporting cycle. Patient or medication safety related continuing education is defined as any ACPE program, as identified by the subject number "05," that deals with the prevention of healthcare errors and the elimination or mitigation of patient injury caused by healthcare errors.

Pharmacists who report CPE this year (i.e., license numbers 03-1-xxxxx) must complete the two hours of "05" CPE prior to the time they renew their license before the deadline of September 15, 2016. The requirement for two hours of "05" CPE also applies to pharmacists who are currently certified by a Board-approved pharmacy practice-specific specialty certification program.

Governor John Kasich signs dynamic, pro-patient legislation to expand pharmacist services and scope of practice to improve health outcomes in Ohio!

In December 2015, OPA informed you that both the Ohio House of Representatives and Ohio Senate voted UNANIMOUSLY to send House Bill 188: Consult Agreements and Emergency Refill Dispensing to the desk of Governor John Kasich, and the governor quickly acted on the bill by signing it into law!

HB 188, which went into effect on March 23, 2016 will

- streamline consult agreement paperwork so that multiple pharmacists can have agreements with multiple physicians to manage drug therapy for multiple patients;
- allow pharmacists acting under a physician consult agreement to order blood & urine tests, analyze the results of those tests, and then to discontinue, change, or add new medications to the patient's drug therapy regimen;
- allow pharmacists to administer drugs when acting within a consult agreement ;
- allow pharmacists to give patients who are out of refills (and if the doctor can't be reached) up to an extra 30-day supply of medications (or the smallest unit of measurement possible), if the patient's life could be adversely affected by not having the medication.

PAC 2015 Recap & Plan

OPA's powerful lobbying team continues to get the job done for our profession:

- aggressive MAC pricing standards established;
- pharmacist's scope of practice expanded through consult agreements;
- Medicaid reforms instituted;
- pharmacists allowed to dispense naloxone without a prescription.

In 2016, OPA PAC contributions will be working toward:

- expanding medication synchronization services;
- granting drug administration authority for pharmacists;
- creating increased accountability for pharmacy technicians;
- leveling the playing field between pharmacies and PBMs;
- formalizing provider status legislation in Ohio.

OPA's efforts are essential for the future of our profession and, with your support, we won't just *talk the talk*; OPA will continue to *walk the walk*.

Thanks to the OPA Medication Therapy Management Committee, and the many other pharmacists and student pharmacists who helped secure letters of support, invited legislators to the pharmacy, wrote letters to legislators, and participated in the OPA Pharmacy Legislative Day & Student Legislative Day.

The refill language is the result of the

tragic loss of a diabetic patient in Northeast Ohio named Kevin Houdeshell.

This bill has been years in the making, and we thank all of the pharmacists, student pharmacists, the Ohio Society of Health-System Pharmacists, the Ohio State Medical Association, the Houdeshell family of Northeast Ohio, and other industry supporters for assisting in its passage. We are thankful for the many OPA members who helped lead the charge to get this bill through the legislature.

Early in 2015, laws went into effect expanding immunization by pharmacists and pharmacy interns, protecting pharmacies from wasteful audits, and permitting pharmacists to fit diabetic shoes. 


