### Let's Not Sugarcoat It: Insulin Safety Matters

Insulin is consistently listed by the Institute for Safe Medication Practices (ISMP) as a high-alert medication, with concentrated formulations presenting additional safety challenges. As obesity rates rise and newer insulin products become more common, use of concentrated insulins has increased. While these agents offer therapeutic benefits, they require careful attention to dosing, pharmacokinetics, and safe-use practices to prevent medication errors. This session reviews current insulin formulations and provides practical strategies for safe selection, initiation, and management across patient populations and practice settings.

### PTSD Pharmacotherapy- Review of Current Standards and Emerging Therapies

Post traumatic stress disorder (PTSD) is a complex

psychiatric condition that often requires a combination of psychotherapy and tailored pharmacotherapy regimens. Recent guidelines continue to recommend longstanding options like selective serotonin and norepinephrine reuptake inhibitors (SSRIs, SNRIs respectively), but give a hierarchy that can be difficult to understand. This session breaks down evidence for why we use the current mainstay agents, common augmentation agents, and why certain medications may not be recommended. Additionally, the session will touch on agents that are currently being studied as novel agents for PTSD treatment, including ketamine and psychedelics.
