Honolulu, Oahu

Hilo, Hawaii



Clothing: There are no formal nights - dress code is resort casual and you will find that Hawaiian shirts and dresses are quite popular. There will be one "Formal or Not" evening where you can dress formally if you want to but it's not required. For Ladies, "Resort Casual" attire means sundresses, blouses, sweaters, slacks, and skirts. For Gentlemen, "Resort Casual" attire means shirts with collars, such as polo shirts, and khakis or trousers. Jeans, shorts, t-shirts, swimsuits, and beachwear are not permitted in the restaurants after 5:30 p.m. (This policy does not apply in casual buffets and select restaurants.)

Weather: Winter in Hawaii is a beautiful season. Weather in the islands should be in the 70s and 80s in the evening mid 60's. "Liquid" sunshine is a possibility, but showers only last a short time. This also is prime whale watching season!

Travel / Health Policy: It is required that persons needing assistance be accompanied by a companion who is capable and totally responsible for providing that assistance. Neither World of Travel nor its suppliers may assist with medications, wheelchairs, or physically lift persons onto transportation vehicles.
